CONTRACTUAL AGREEMENT

THIS LAND IS STRICTLY FOR THE PARKING OF MOTOR VEHICLES THAT COMPLY WITH THE FOLLOWING CONDITIONS INDICATED BELOW.

VEHICLES COMPLYING WITH THE ABOVE TIME STAY LIMIT AND DISPLAYING A CURRENT VALID DISABLED BADGE MAY PARK IN DISABLED BAYS. THE BADGE MUST BE DISPLAYED INSIDE THE FRONT WINDSCREEN WITH ALL APPROPRIATE DETAILS CLEARLY VISIBLE.



VEHICLES MUST NOT PARK ON THIS PRIVATE LAND EXCEPT WHERE PARKING BAYS ARE PRESENT. VEHICLES MUST ONLY PARK FULLY WITHIN AN AUTHORISED MARKED BAY AND MUST NOT PARK ON, OVER OR OUT OF THE LINES FORMING THE BAY.



NO BUSES, COACHES, CARAVANS, LORRIES OR HGV'S.



IF YOU PARK A VEHICLE ON THIS LAND AND ARE NOT FULLY COMPLYING WITH THE CONDITIONS LISTED ABOVE YOU ARE CONTRACTUALLY AGREEING TO ONE OR MORE OF THE FOLLOWING:

A PARKING CHARGE NOTICE BEING ISSUED AND A CHARGE OF £100 BEING ENFORCED, DISCOUNTED TO £60 IF PAYMENT IS RECEIVED WITHIN 14 DAYS (FAILURE TO PAY WILL LEAD TO COURT ACTION FOR RECOVERY & WILL INCUR ADDITIONAL COSTS)



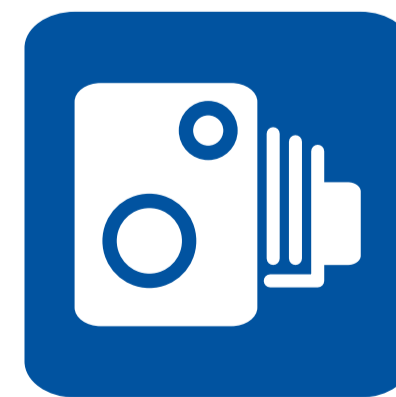

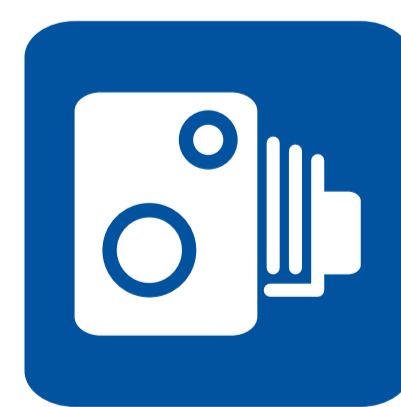

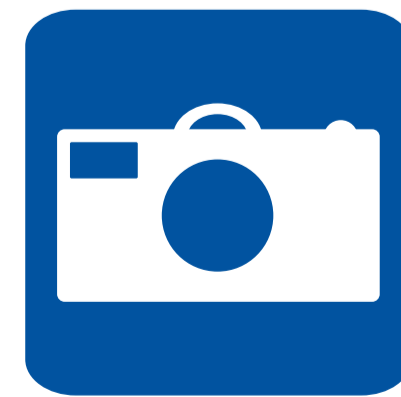
